RESTRICTIONS

The Parks, Recreation and Cultural Resources Department reserves the right to approve or deny an application on a case-by-case basis. Permits may not be issued for programs or services that are considered high risk, are already offered by the department, are considered to be a nuisance to the neighborhood or surrounding areas, require equipment to be placed in the park, negatively impact traffic or the public's ability to use and enjoy a park, or any other factor that may impact the public's health, safety and welfare, as well as programs and service deemed inappropriate by the Parks, Recreation and Cultural Resources Department. A permit may be revoked at any time by the Director for a violation of the permit conditions; a violation of any rules, ordinance; or if it is determined the permitted use constitutes a threat to the health and safety of the public.

To the fullest extent permitted by law, the undersigned shall defend and hold harmless the Town of Garner, its agents, representatives, officers, directors, officials and employees from and against all claims, damages, losses and expenses (including but not limited to attorney fees, court costs, and the cost of appellate proceeding) relating to, arising out of, or alleges to have resulted from the acts, error, mistakes, omissions, work or services of the permit. The permit holder's duty to defend, hold harmless and indemnify the Town of Garner, its agents, representatives, officers, director, officials and employees shall arise in connection with any claim, damage, loss or expense that is attributable to bodily injury, sickness, disease, death, or injury to, impairment, or destruction of property including loss of use resulting there from or cause by and acts, errors, mistakes, omissions, work or service in the performance of the permit including any employee of the permit holder or an tier of subcontractor or any other person for whose acts, errors, mistakes, omissions, work or services for which the permit holder may be legally liable.
